The Wacom Board of Directors has decided to issue a dividend payout from surplus earnings to investors appearing on the shareholders' list as of March 31, 2009.

2. Reason

Wacom's dividend payout policy is to maintain stable payouts to ensure future business development and reinforce the financial base. The payout ratio is targeted to be more than 30% on a consolidated basis and increased in the long-term in order to attract global investment into the Company.

As for FY08 (ended March 31, 2009), the Wacom Board of Directors has given priority to maintaining stable payouts and decided to pay a dividend of ¥3,000 per share, based on the view that the current severe business environment is temporary, although the net profit for FY08 was lower than its initial forecast. As a result, the payout ratio for FY08 is 48.3%.
